The research will be carried out by PI Barbara Turk Niskač at the Faculty of Education and Culture, Tampere University.

7. Content of research records

Personal data processed includes contact information, name, year of birth, place of living, education and occupational status, voice and facial features/physical appearance.

8. Sources of personal data

Research participants will be asked to fill out a questionnaire with contact information, name, year of birth, place of living, education and occupational status. The questionnaire will be marked with the identification number. Collective biography workshops and sensory walks will be audio, photo and video recorded which will be the source of voice and facial features/physical appearance. Data gathered through Citizen Science will include a questionnaire with contact information (e-mail), name, year of birth as well as visual material and written accounts shared by research participants. These will also be the source of facial features/physical appearance.

9. Purpose of processing personal data

The purpose of processing personal data is scientific research.

The purpose of this study is to explore contemporary subsistence practices and to document intergenerational memories of children's participation in subsistence practices and hitherto related relations with human and more-than-human world. The research project will point to the importance of work related to subsistence practices for biodiversity and sustainable food production. Research findings will be disseminated for academic and educational purposes via scientific articles, a monograph, conferences, writings for lay audiences, project website and FB page, and a museum exhibition at The Slovene Ethnographic Museum.

Data gathered with sensory walks will provide new knowledge on micro-processes of relational, affective, and material entanglements of human work and more-than-human reciprocity. Data gathered with collective biography workshops will point to social, economic, and cultural structures as they are shaping and being shaped by generational and more-than-human relations and in an intersectional manner. Processing personal data will enable an analysis of collected subsistence practices through the prism of intersectionality: how do age, gender relations and social class (education and occupational status) relate to children's participation and the ethics of sustainable practices (e.g. a gendered division of work and care). The results of the analysis of transcripts and visual material will be presented in scientific articles and a monograph.

Selected visual material, audio recordings, written stories and memories will be used for dissemination on the project's webpage, FB page, and in the museum exhibition at The Slovene Ethnographic Museum. In the informed consent, research participants will choose whether they want their collected personal data (name, year of birth, place of living) to be published or anonymized along material presented in the project webpage, FB page, at the exhibition and in the archives and whether they allow the publishing of visual material.

The project also includes *Citizen Science* as collaborative knowledge and data production, where members of public will be invited to participate by sharing their own childhood memories and stories of subsistence practices by submitting visual material (pictures) accompanying with written accounts. Before submitting their material through Citizen Science webpage, participants will be informed about the conditions of participation in this action and will need to agree to give the rights to use the material for research, dissemination and communication purposes. The submission form will contain a box the participants will tick and therefore express their consent and a box where they will tick whether or not they give permission for their name and year of birth to be published along the material.

The goals and expected benefits of the research project are described in a separate information sheet, which will be given to the research subjects.

Selected visual material, audio and written accounts will be disseminated on the project website and FB page.

Before transcripts will be published in ADP, the ADP staff will make the quality check of all the data and in case of potentially sensitive data, the transcripts will be anonymized accordingly.
